## ATHLETES MUST SKI AT A CONTROLLED SPEED AFTER FINISHING THE LOWER SECTIONS. NO TUCKING OUTSIDE OF THE TRAINING VENUE

**REGISTRATION** will be on the **Second floor of the Main Base Lodge.** Entry Fee with lift ticket-\$35. MUST be paid with exact cash.

Athletes must be included on the SVC Start List by Thursday, February 8 and be current USSA & VARA members. No athletes will be added to the start list on the morning of the event.

Discounted lift ticket vouchers for the day of the event will be available at registration. The vouchers are for \$39 tickets and you bring them to any ticket window to pay for and redeem them. Limit is 2 per athlete. The vouchers will only be available on the second floor of the Main Base Lodge from 7:30-8:30am.

Only USSA & VARA approved coaches are allowed on the race trail. All coats should be run via Exhibition to Somerset Rd ski trails.

Due to the nature of speed events, the venue will be closed to spectators. Athletes will be cycled through stations with coaches.

Bib Return is on the 2<sup>nd</sup> Floor of the Training Center

Slow skiing while not on the race course!
