Pulls are due by Sunday, February 14 at 9:00am (online processing fees are not refunded). No refunds after pull deadline. VARA team members email entry by entry deadline to [picoskiracing@gmail.com](mailto:picoskiracing@gmail.com). No event day registration.

Bib and ticket collection: All athlete bibs and coach tickets should be picked up at registration headquarters, located in the Andrea Mead Lawrence Lodge at Pico Mountain.

Coaches Tickets and Registration: Coaches tickets are available to those coaches with current USSA and VARA registrations who are onsite for the race. Tickets are collected at race registration. Any discrepancies will be addressed by the Race Administrator at the coaches meeting.

Racer Lift tickets: Lift ticket fee is included in entry fee; tickets are distributed with bib at registration.

Bib Fee: \$100 will be billed to any athlete who did not return his/her bib.

Day Storage for visiting athletes: Attendees use the Pico Mountain base lodge well as the new Slope Side Loft attached to the Pico Mountain Sports shop for day storage. The Pico Ski Club located at the bottom of the race course is a private facility. Please respect the membership's privacy.

TEAM PARKING: All team vans need to park on skier's right of the mountain in the condominium unit lots; please no van parking in the main lots.

Program of events:

Mandatory Team Captains' Meeting: 7:45, downstairs of Pico Ski Club; sign-in is required.

Little Pico Triple Lift opens: 7:30 AM for Jury and Race Crew; 8:00 for athletes and coaches

Inspection: 8:00-8:45

Forerunners: 9:05

First Run 9:15 girls; boys to immediately follow the completion of first-run girls

Subsequent runs:

- 2<sup>nd</sup> run will be set directly following completion of first run
- 2<sup>nd</sup> run inspection will begin 1 immediately following set
- 2<sup>nd</sup> run course inspection for ½ hour
- 2<sup>nd</sup> run begins after inspection closes

Rules: All USSA and VARA rules are in effect. Rule 621.11.3 regarding second runs for DNFs and DSQs will be discussed at Team Captains meeting.

Scoreboard: Unofficial results will be posted on the scoreboard located on the Pico Ski Club building at the bottom of B Slope.

Disqualifications/Protest Period: Disqualifications will also be posted on the scoreboard with a 15 minute protest period following the posting. Protests are accepted with a \$20 fee applied.

Awards: Presentation will be from the Pico Ski Club deck (at base of the race course) following conclusion of protest period.

Race course located on B Slope, skiers left side of lower-mountain; please no free-skiing on the trail.

Family lift tickets: \$45 per ticket and available for purchase at the Pico Mountain ticket office; limit of 2 tickets per racer family.
